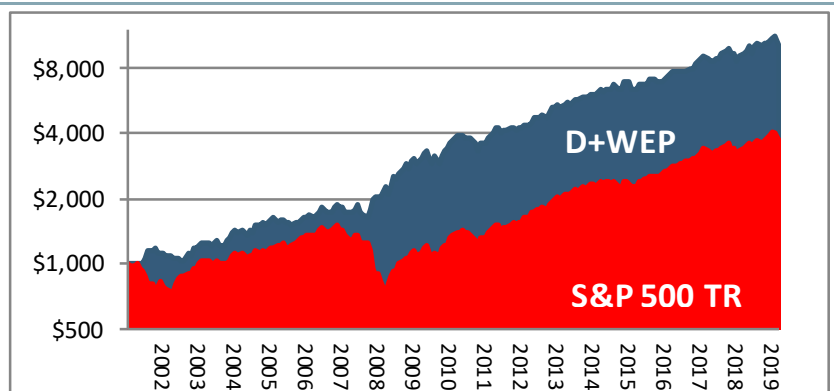

Dauble+Worthington Equity Portfolios ("D+WEP") is a registered investment adviser located in the state of Indiana. D+WEP serves as an investment advisor and determines all asset allocations within the portfolio. Dauble+Worthington Equity Portfolios may only transact business in those states in which it is registered, or qualifies for an exemption or exclusion from registration requirements.

### Performance Disclosure:

For the period of January 2002 through August 2015, this presentation represents a hypothetical backtest of an allocation to the D+W Equity 102 portfolio. Performance from September 2015 to the present is based on a blend of actual accounts managed by D+WEP. Individual returns may vary substantially from those presented due to differences in the timing of contributions and withdrawals, account start dates and actual fees paid. All performance is presented net of the current advisor fee for the program, 1.75%, paid quarterly in advance. The hypothetical performance results shown include the reinvestment of dividends and other earnings. Performance is not net of custodial fees.
