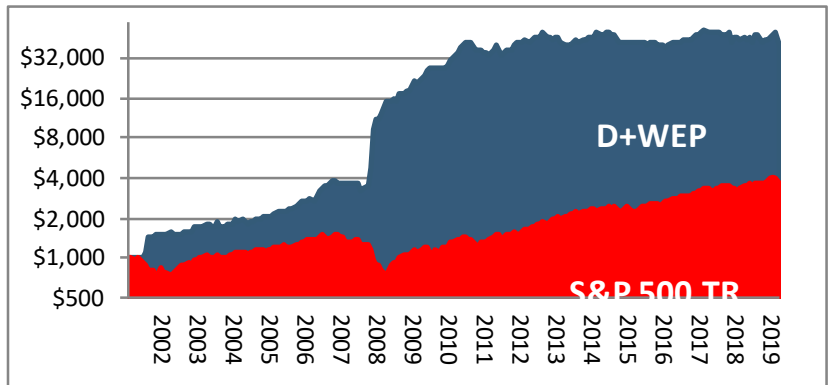
D+W ROW 2.0

The model follows proprietary trend and relative strength indicators and seeks to achieve its investment objective by investing in specific mutual funds through ProFunds which include leverage and short positions. It may invest in, and may shift frequently among these funds and money markets.

Dauble+Worthington Equity Portfolios ("D+WEP") is a registered investment adviser located in the state of Indiana. D+WEP serves as an investment advisor and determines all asset allocations within the portfolio. Dauble+Worthington Equity Portfolios may only transact business in those states in which it is registered, or qualifies for an exemption or exclusion from registration requirements.

Performance Disclosure:

For the period of January 2002 through December 2009, this presentation represents a hypothetical backtest of an allocation to the D+W ROW 2.0 portfolio at ProFunds. Performance from January 2010 to the present is based on actual accounts managed by D+WEP. Individual returns may vary substantially from those presented due to differences in the timing of contributions and withdrawals, account start dates and actual fees paid. All performance is presented net of the current advisor fee for the program, 3.00%, paid quarterly in advance. The performance results shown include the reinvestment of dividends and other earnings. Performance is not net of custodial fees.

The D+WEP portfolio results reflect hypothetical performance that was achieved by means of the retroactive application of an allocation back test and, as such, the corresponding results have inherent limitations, including: (1) the portfolio results do not reflect the results of an actual account allocated in this current portfolio of mutual funds, but were achieved by means of the retroactive allocation to mutual funds available on the ProFunds custodial platform, certain aspects of which may have been designed with the benefit of hindsight; (2) backtested performance may not reflect the impact that any material market or economic factors might have had on the adviser's use of the portfolio if the portfolio had been invested during the period to actually manage client assets; (3) for various reasons (including the reasons indicated above), D+WEP's clients may have experienced investment results during the corresponding time periods that were materially different from those portrayed in the model.
